About Feed-in Tariffs

Feed-in Tariffs (FITs) are a buy-back scheme for wind, hydro, anaerobic digestion, solar photovoltaic (PV) and micro CHP generators. FITs are designed to offer greater financial incentives for generating your own renewable energy.

When we receive your application it will be checked and registered onto the FITs central register which is administered by Ofgem.

Ofgem will then confirm to us when the installation has been registered for FITs.

We will then send you a FITs Statement

of Terms which will detail the Terms and Conditions and all the necessary information you will need for the duration of the contract. Please review this and send it back to us.

Once your installation is signed up to FITs we will backdate your payments to the date we received the completed application form. This will become your eligibility date.

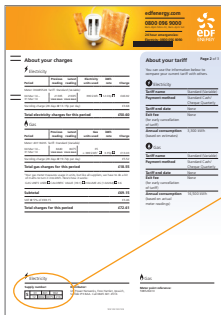
